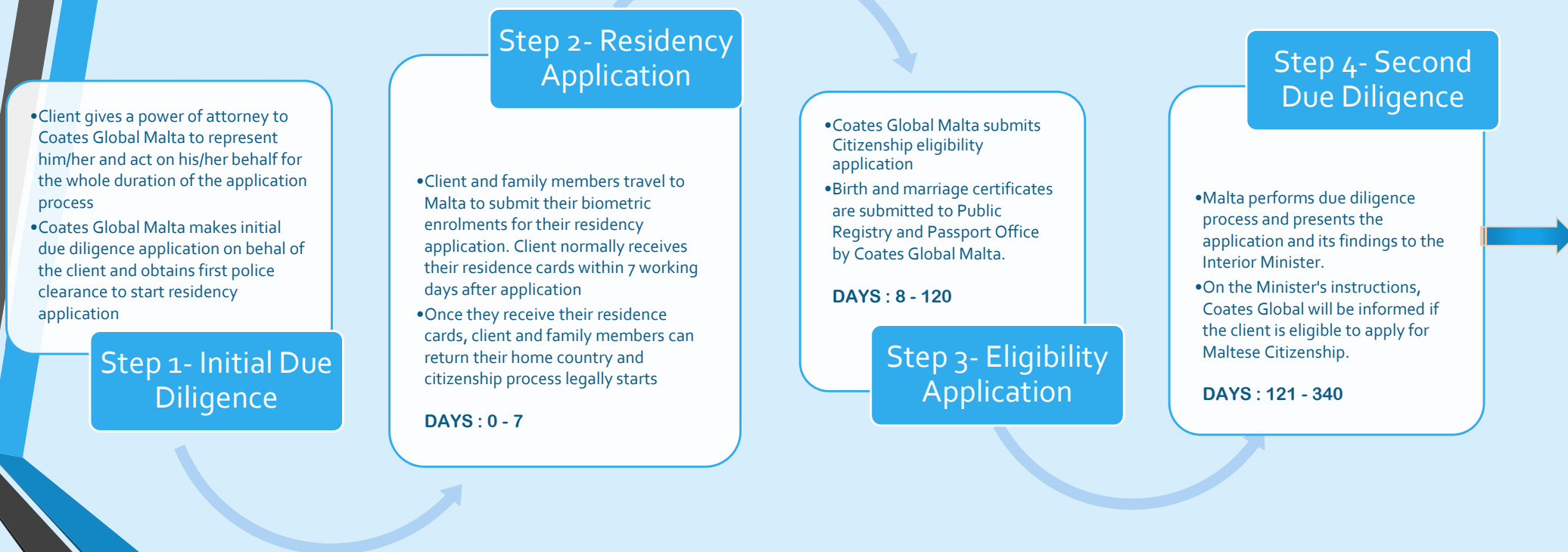
## How Can You Apply?

To be eligible you must:

- Be at least 18 years of age; and
- Be in good health i.e. not suffering from any contagious diseases; and
- Contribute a non refundable contribution of
  - at least €600,000 if you wish to become a citizen after 3 years
  - or
  - at least €750,000 if you wish to become a citizen after 1 year
- Purchase a residential property valued at least €700,000 or enter in to a property rental agreement for a minimum of €16,000 per annum for 5 years; and
- Donate at least €10,000 to a registered charity in Malta.
