- USD 200,000 – Single applicant
- USD 250,000 – Main applicant with spouse or a family of up to four
- USD 50,000 – Per additional dependant



OPTION 2: APPROVED REAL ESTATE INVESTMENT

Investors may choose to purchase property in a government-approved real estate project, such as luxury eco-resorts or boutique hotels.

Minimum Investment Requirement

- USD 200,000 – Real estate purchase
- Holding Period: Property must be held for a minimum of 3 years (5 years if resold to another CBI applicant)

Government Fee (Real Estate Route)

- USD 75,000 – Single applicant
- USD 100,000 – Family of up to four
- USD 25,000 – Per additional dependant

OTHER FEES (ALL ROUTES)

In addition to the investment, the following fees apply:

- **Application Fee:** USD 1,000 per application
- **Due Diligence Fees:**
 - USD 7,500 – Main applicant
 - USD 4,000 – Per dependant aged 16+
- **Passport Fee:** USD 500 per person

- **Legal & Administrative Fees:** USD 10,000 + USD 1,500 per dependant

Note: All applicants aged 17 and above must complete a mandatory virtual interview during the due diligence phase.
