UK Self-Sponsored Skilled Worker Visa

This visa program is designed for entrepreneurs who seek to establish their business presence in the UK. It provides a streamlined avenue to residency, bypassing the need for third-party endorsements. The primary requirements are the establishment of a bona fide UK business and B1 level English proficiency for the main applicant.



Key Requirements

- Establish a genuine UK-based business (e.g., tech company, hair salon, consultancy)
- Own 100% of the business or enter a partnership
- Business must be viable and capable of meeting market needs
- B1 level of English proficiency
- · No minimum investment required

Can my family join me in the UK with this visa?

Your spouse and children under 18 are considered dependents and can be included in your visa application, enabling you to move to the UK as a family unit.

What are the English language requirements for me and my dependents?

As the main applicant, you must demonstrate English proficiency at B1 level. Your dependents are not required to prove their English skills initially; however, for any dependents over 18, including your spouse, B1 level English is required when they apply for Indefinite Leave to Remain (ILR) after five years.

Are there specific types of businesses that qualify for this visa?

There are no specific restrictions on business types; whether it's a startup or an established business model, it must be legitimate, viable, and capable of fulfilling market demands within the UK. The emphasis is on establishing a bona fide business that is capable of success and growth within the UK economy.

What is the expected timeframe for the visa application process?

The duration can range from 3 to 10 months, influenced by the nature of your business and your individual circumstances.

Must I reside in the UK once I obtain the visa?

Not necessarily. However, to qualify for Indefinite Leave to Remain, you should not exceed 180 days of absence from the UK in any 12-month period within the five years prior to your permanent residency application in the future. This applies to both you and your spouse, but not to your children.

Is a minimum investment required for the business?

No minimum investment is mandated, but your business should have sufficient funding to ensure smooth operation and growth potential.

What if my business does not succeed while I'm on the visa?

It's vital to consult with legal experts promptly. Although business failure may impact your visa status, alternative options could be available depending on your case.

Can I take on additional employment?

While your primary focus should be on your business, you are permitted to undertake additional work within the field of expertise, as long as it doesn't compromise your business activities.

Is British citizenship attainable through this programme?

Yes, after a continuous five-year residency period in the UK, you're eligible to apply for permanent settlement. Following one more year, you may qualify for British citizenship.





What expenses should I anticipate beyond the visa fees?

When planning your move to the UK on the Self-Sponsored Skilled Worker Visa, it's crucial to budget for several additional expenses such as visa application fees and IHS-Immigration Health Surcharge which is approximately £624 per person for each year of the visa. (This will increase to £1,035 on 16 January 2024.) Legal fees will vary based on the complexity of your case and the services you require. Business establishment costs can also vary widely depending on the nature and scale of your business. Additionally, you'll need to ensure you have enough maintenance funds to support yourself and any dependents without access to public funds.

How do I decide the length of my initial visa, and why might I choose a shorter visa period?

The duration of your visa can be selected based on your personal preference and financial planning. A five-year visa offers the peace of mind of long-term stability in the UK, but it also requires a larger initial financial outlay, as you must pay the Health Immigration Surcharge for the entire period upfront, as well as potentially higher visa fees. Some applicants may prefer a shorter visa duration to decrease initial expenses. The choice should be made considering both your immediate financial situation and your long-term plans in the UK.
